Dear Principal,

As you are aware, the National Council for Hotel Management & Catering Technology (NCHMCT) has conducted the OET Round-1 Examination for filling the residual vacancies in the **Three-Year B.Sc. (Hospitality & Hotel Administration) Programme** for the Academic Session **2026–27**. The result of OET Round-1 is under process for publication.

2. In continuation of this office D.O. Letter of even number dated **25.06.2026**, the second round OET i.e., OET Round-2 Examination is proposed to be held on **15.07.2026 (Wednesday) from 11:00 AM to 12:00 Noon**.

3. All affiliated Institutes are requested to facilitate the registration of eligible candidates through the same User ID provided for the Institutional Login Portal (<https://nchmct.in>). The particulars of each candidate should be entered carefully on the portal. After successful registration for OET Round-2, the same procedure for uploading of necessary documents and remittance of non-refundable and non-adjustable Registration Fee of ₹2,000/- (Rupees Two Thousand only) is followed as done in case of OET Round-1.

4. It may kindly be noted that the Registration Fee paid by a candidate shall be valid **only for the OET Round for which the candidate has registered** and shall neither be refunded nor adjusted against any subsequent OET Round.

5. Institutes are advised to ensure that candidates verify the correctness of their **Email ID** and **Mobile Number** before submission of the application, as all future communications relating to the examination, seat allotment and admission shall be communicated through the registered Email ID and the Admission Portal.

6. The registration facility for **OET Round-2** shall remain open up to **13.07.2026 (Monday) till 4:00 PM**. Thereafter, the registration link for Round-2 shall be deactivated automatically. You are, therefore, requested to ensure that all eligible and interested candidates are registered well before the closing date so as to avoid last-minute difficulties or technical issues.

7. The **Roll Number** generated after successful registration shall be required for accessing the online examination. Institutes are advised to communicate the Roll Number to the respective candidates immediately after registration and advise them to preserve the Roll Number and login credentials carefully. Any discrepancy in the Roll Number or candidate identity during the examination may result in cancellation of candidature after due verification by NCHMCT.

8. Further, upon generation of the Roll Number to the registered candidate, the candidate may log in to the portal using his/her registered Mobile Number or Email ID as the User ID and the allotted Roll Number as the initial password. The candidates may also be suitably advised to change their password immediately after their first login to ensure the security and confidentiality of their login credentials. This login facility will enable candidates to access the examination link, view the examination scheme, check their result and allotment status, and download the allotment letter directly through the portal itself.

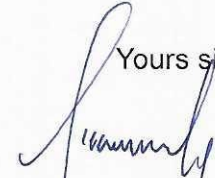
